#### What Information Is Collected

To complete the account creation process, we will need:

- Your name
- Your email address
- Your child's name
- Your child's email address

We will not ask for any further information than this.

# Why We Collect This Information

This information is collected to allow identification of your and your child's accounts on our website. If you grant consent, we will create an account for both you (if you don't already have one) and your child using the information provided. We will also link your accounts within our system so we know that you have granted consent for your child's account. You will both be able to log into your respective accounts using your email addresses as your usernames, and can use your email addresses to reset your passwords if necessary.

## Who Has Access to This Information and Why

Lockheed Martin Code Quest® Academy is a volunteer program operated by Lockheed Martin Corporation. All volunteers are Lockheed Martin employees. A small number of volunteers who maintain the Code Quest® Academy website will have access to your information as part of their efforts to maintain that website and protect your information. All collected information is stored in an encrypted database hosted on Amazon Web Services on servers within the United States.

The Code Quest Academy website includes a "class" feature that allows users to join a class created by another user on an opt-in basis. Joining a class as a "student" allows the class's creator to view your name and your most recent solution to each of the problems you've attempted on the website. Creating a class allows any potential "students" to view your name. This feature functions on a purely opt-in basis, meaning no information is shared if a user does not utilize these features. Email addresses are never displayed within the website.

Lockheed Martin does not share, sell, rent, or transfer personal information except as noted above or as required by law.

#### How We Use This Information

As noted above, information we collect about you and your child is used for identifying your accounts within our website and allowing you and your child to access the website and its features. We have collected your email address from your child for the purpose of sending you this form, however your email address has not been stored at this time.

### **How We Protect This Information**

All information we collect is stored in an encrypted database, and can only be accessed by individuals with a need to access that information. We maintain all reasonable precautions, including appropriate technical and organizational security measures, policies, and procedures in order to protect personal information against unauthorized access, disclosure, and misuse. We also regularly delete inactive accounts from our system along with all personal information associated with those accounts.

## Your Rights Regarding This Information

As your child's parent or legal guardian, you retain full rights to your child's personal information. In particular, you have the right to:

- Review what information we have collected for your child at any time
- Request corrections to the information we have collected for your child
- Revoke your consent for us to collect or retain your child's personal information
